Sir/Ma'am,

With reference to the letters on the subject cited above, I am directed to convey No Objection of the Government of Assam in Medical Education & Research Department for starting of Degree / Diploma in Pharmacy course to NEPEDS College of Pharmaceutical Sciences (NCPS) Tetalia, Sonapur, Kamrup(M) Guwahati from the session 2022-23 onwards.

This NOC is subject to the following conditions:

1. The NOC does not amount to grant of permission for starting college/course or for admissions which will be granted as prescribed by concerned Regulatory body / SSUHS.
2. The institution shall fulfill all requirements with regard to physical infrastructure, clinical facility and teaching facility as laid down by the Government/ SSUHS, **within one year from the date of issue of this NOC.**
3. Periodic reviews will be conducted by Government to verify compliance with all requirements by the institute.
4. Any inspection carried out after issue of NOC will be jointly undertaken by the officials nominated by DME, Assam and SSUHS.
5. All copies of the reports of inspection carried out from time to time will be submitted by the Institute to this Department.
6. The institute will furnish an agreement with the affiliated/ parent hospital for clinical exposure as required which will clearly state that such an arrangement will not exceed prescribed students patient ratio, in order to the avoid overcrowding of hospital which in turn may lead to inadequate clinical exposure of students along with deterioration of patient care.

This document will be furnished to Government within a month of issue of NOC to State Government with copies to DME and University.

1/127073/2023 7. The institution shall obtain approval and affiliation from SSUHS and send copy of the same to Government.

8. The institute shall not admit any student, prior to attaining affiliation of the courses from SSUHS.

9. The institute shall not admit more students, other than the approved capacity by SSUHS.

10. The institutions shall furnish its annual report to the Government as well as University.

11. The Government may impose any other condition(s) at any time, which shall be binding on the institute.

12. Failure to comply with the above conditions will lead to withdrawal of the No Objection Certificate and action deemed fit shall be taken against the institutions.
